Visa Application Procedure

You will need a passport in order to apply for your visa. If you do not have one, please apply immediately and pay to expedite the passport application.

SAI will process student visa applications for students residing within the jurisdiction of the **Boston, D.C., Detroit, Houston, Miami, New York, Philadelphia, and San Francisco** Italian Consulates. Students may complete their application for a student visa based on the Italian Consulate in their home jurisdiction or to the Italian Consulate in whose jurisdiction they attend school. Students with European Citizenship do not require a visa.

Please note that it is a student's responsibility to submit ALL required materials by the due date to SAI. Incomplete applications will not be processed. Students without a proper visa may be unable to attend school in Italy. Furthermore, SAI cannot guarantee the timely return of your passport and visa if these deadlines are not met. If you plan to depart several weeks prior to the start of classes, or will need your visa prior to the start of your program, you will be responsible for obtaining your student visa. This holds you responsible for ensuring that you have your passport & processed visa in time for your departure. Please contact the visa coordinator immediately.

If you will be attending multiple sessions, be sure to notify SAI's California office of your plans as soon as possible. Obtaining a visa for your entire period of study requires that you submit a program application and the required deposits and fees for all terms so acceptance letters may be issued for the full period of study and can then be submitted to the Italian Consulate. You must apply for the full period of study before you depart as it is not possible to obtain a student visa or to extend a student visa while in Italy.

It is MANDATORY that all students who will be submitting their visa application to SAI do so no less than 75 days prior to departure.

With that in mind, please send the required materials to SAI as early as possible, as we can begin your visa process 90 days prior to departure.

If you do not meet the deadline of submitting your visa application materials to SAI, you may be responsible for applying on your own for your student visa.

It can take anywhere from 30 to 60 days (in some cases, it may take more or less time depending on the particular Italian Consulate) for your visa to be issued and returned with your passport to SAI after the Italian Consulate receives it. SAI will return your passport & processed visa (which is attached to a page in your passport) to you in the prepaid, self-addressed, Express Mail envelope you have provided.

COST: \$250 For those students submitting their visa application to SAI.

If you wish to apply on your own, you will need to verify the specific requirements of the Italian Consulate in your jurisdiction. **Please contact SAI to request the additional letters (Letter of Enrollment, a Letter of Acceptance from the Italian Institution, Insurance Letter and your Course Schedule) that complete your visa application.**

Italian Consulates have the full authority to evaluate and request additional documentation, if deemed necessary, in addition to what is submitted. Submitting all required documentation does NOT guarantee the issuance of any particular visa.

CHECKLIST:

- You must submit all documentation in ORIGINAL PLUS 1 SET OF COPIES.**
- Original Passport** with a validity that exceeds intended stay by at least 3 months (90 days). The passport must have a full blank page on which the visa can be affixed.
- One recent passport photo** glued to your visa application where specified.
- Photocopy of Passport** (photo & signature page only). Please ensure that you have signed your passport.
- Photocopy of Drivers License, State ID or University ID** (whichever provides proof of residency in the Consulate's jurisdiction). Please ensure that it is a clear copy.
- Non-US students must have a valid I-20 and exchange visitors a valid DS2019 or US Alien Registration Card.** Please include a photocopy of your F-1/ J-1 visa and your I-20/ DS2019 or US Alien Registration Card.
- Visa Application** filled out completely, with your signature **NOTARIZED.** Please ensure to list your **MOTHER'S MAIDEN** name for **#12** on the Visa Application. The Italian Consulate will render applications with white-out, crossed out or written over answers invalid. If you make a mistake while filling it out, please download a new application.
- Affidavit of Financial Support** (only if someone other than the student will be financially responsible for the student). In signing the affidavit of financial support, the parent or guardian must provide proof of adequate financial means. This signature must be **NOTARIZED.**
- ORIGINAL Bank Statement, Bank Letter or Financial Aid Letter** **(NO PHOTO COPIES OR ONLINE PRINT OUTS)** Consulate will accept bank printout if it is stamped and signed in blue ink, with business card attached.
Recent Bank Statement -checking or savings or **Bank Letter** on letter head from bank (student, parent or legal guardian's bank) with the balance of the account(s) showing monetary stability (\$1000 per month while in Italy) This bank information will be the student's or the person signing the Affidavit of Financial Support. **Financial aid students** may instead attach the official letter from the institution that has granted the aid, indicating the amount allocated in their name
- Flight Itinerary** for a round trip ticket.
- Pre-paid and self-addressed Express Mail Envelope that can be tracked** (USPS or FedEx). Signature required. **Remember to retain your tracking number.** Your passport and visa will be returned to you in this envelope. Be sure you will be living at the address provided, or that someone will be there to forward your passport to you quickly.
- SAI visa processing fee:** \$250, made payable to Study Abroad Italy. Please ensure to list the applicant's name on the check.

*** **All of the above items must be sent to our office by EXPRESS MAIL ONLY (USPS, or FedEx)**
Please do not include other Study Abroad Italy payments or correspondence with your visa materials. It is advisable that you make a copy of your visa application materials for your personal files.

INSTRUCTIONS ON COMPLETING THE APPLICATION FOR THE SCHENGEN VISA

21. Main destination: **(City), Italy** (Location of program)
22. Type of Visa: Circle **Long stay** (for Semester and Year Programs), Circle **Short stay** (for Summer Programs)

24. Number of entries requested: Circle **Multiple Entries**

25. Duration of stay: **List the number of days of the term. Count ONLY the number of days of the program from Housing Check In until the last day of final exams, EVEN IF YOU ARE ARRIVING A FEW DAYS BEFORE OR LEAVING A FEW DAYS AFTER THE PROGRAM.** For 2 semesters count from Housing Check In of the first term until the last day of final exams of the second term.

26. Other visas (issued during the past three years) and their period of validity:

27. In case of transit, have you an entry permit for the final country of destination? Your final destination is Italy so this does not pertain to you. **Write N/A**

28. Previous stays in this or other Schengen states: **List any previous stays in the Schengen area – (list the country and date).** The Schengen area includes: Austria, Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Italy, Luxemburg, The Netherlands, Norway, Portugal, Spain, and Sweden. **Otherwise answer No.**

29. Purpose of travel: Circle **Cultural/ Sports** and write **student** on the dotted line.

30. Date of arrival: **Actual date you will arrive in Italy**

31. Date of departure: **Actual date you will depart Italy**

32. Border of first entry in the Schengen area: **This is the place your flight first lands, (ex. France, Germany, or any of the Schengen states), before arriving in Italy**

Some applications ask for the Border of Entry in Italy: **List the first city in Italy you arrive in**

33. Means of transport: (into Italy). List **plane** or **train**

34. Name of host or company in the Schengen states and the contact person at host-company. If not applicable, give name of hotel or temporary address in the Schengen states: **List the Name, Address, Telephone, & E-mail of the School you will be attending in Italy:**
